Task Force to Review Discipline Procedures (Again)

The Board of Governors of the Washington State Bar Association has appointed a task force to review the Rules for Enforcement of Lawyer Conduct (ELC). This is the next step in a review process that has been going on for two years.

In 2006, a committee of the American Bar Association reviewed Washington's professional discipline system. They issued a report in August that recommended several far-reaching changes. They recommended that the Disciplinary Board and the Office of Disciplinary Counsel be removed from the Bar Association and placed directly under the Supreme Court. They recommended that the Disciplinary Board sit in panels in review cases, rather than acting as a full Board. They also recommended many smaller changes, such as better use of technology and better training for hearing officers.

This report was reviewed by the Discipline Committee of the Board of Governors. That committee issued a report in September, 2008. The report recommended against any major structural change. It did adopt most of the other recommendations of the ABA committee.

The Board of Governors has now appointed a Task Force to review the operation of the discipline system and recommend any necessary changes. The Task Force charter, the two reports, and other documents can be viewed on the WSBA web site at <http://wsba.org/lawyers/groups/elctaskforce.htm>.

Seth Fine, as Vice Chair of the Disciplinary Board, is a member of the Task Force. He is soliciting suggestions for improvements to the attorney discipline system. Any ideas can be sent to him at sfine@snoco.org *et*

THE LAWYER'S ROAD
REVIEW

Perspective

This week in my office, I opened the statement from my IRA that was printed on Halloween. May I say I have not had such a fright in the longest time? I considered jumping out of my office window but then realized I am on the first floor. Instead, my eyes rolled skyward and happened to glance at the framed certificate the Supreme Court issued to me granting my license to practice. I noted the license was signed 25 years ago this same week. Another 25 years to go, apparently, given the state of my "pension."

Shouldn't there be a lapel pin or something issued after 25 years of membership in the bar, even though the market has dictated that I am only half way to retirement?

We in private practice are a randy bunch, aren't we? Unable or unwilling to slog through the years of a "job" somewhere forever chained to the ostensible security of a larger company than ourselves, we pretty much are modern day hunter gatherers. Free from the dictates of so called superiors, we eat what we kill, recklessly send our children to a better school than we attended and, with any luck, retire with modest dignity. But the elements of risk are always there.

The subject matter we handle is often difficult. I saw one of my partner Spalter's clients coming in for a consult and could have sworn it was Marge Simpson, finally divorcing that loser Homer. It got me thinking that, like Homer, we handle nuclear waste much of the time. We stress about it and sometimes it spills over into our lives and our practices. Is it any wonder we sometimes get irritated?

Here is my advice after 25 years: Don't do that. This is, in reality, just a job. The clients come to us with problems and the best we can do is provide some kind of remedy that is not

as bad as if the lawyer was not involved at all.

Something else I have learned: Contrary to the belief of the clients, the lawyer doesn't know everything, and cannot control events. The lawyers should understand this as well, and retain that collegiality that renders us a noble profession. What I tell clients is negotiating a bad settlement is generally preferable to trying a good case. Things can go very bad quickly if you forget this rule. Anyone who has practiced any length of time knows this. Perhaps the following story is your best shot at convincing the clients of this truth.

A man named Gavrilo Princip shot Archduke Ferdinand and his wife Sophie on a beautiful June day in Sarajevo in 1914. The Austrians thought they ought to have a hand in investigating the assassination, given it was their leader who died, a modest request to my mind.

The Serbs rejected the request. Austria felt it had to do something under the circumstances, so went to trial, or in other words, declared war. They did not know Russia would be then declaring war against Austria, and a whole list of other countries were compelled by other unknown alliances to join in. In the end, we had World War I. World War I ends in the Treaty of Versailles, setting up World War II, which ends with the world with an atom bomb on its hands and the ultimate price for humanity for World War III.

Somehow I don't think Serbia considered this possibility when rejecting Austria's reasonable request. Sure, the Austro-Hungarian Empire fell, which was the objective of Princip as well as some Serbians, but considering the fact Princip was a terrorist, Serbia would have been better off with a few Austrians on the CSI team rather than be identified with him.

So when advising to your client Serbia, unwilling to bend at all, you can say failure to negotiate may mean you have no Austrians in your country looking under every door mat, but at the end of the trial you also have a lot of dead Serbs. And look at all those fine young men dying in Flanders. Did you think about that Serbia? Not only that, your historical ally Russia became a communist totalitarian state. Go ahead and say you didn't know that would happen, that you had a right to put up road blocks to discovery, or that you have a historical fight with the other party and

his lawyer, but that doesn't change the outcome. So why go down that road? Now we have The Bomb to worry about and with it the End of History. All because of a lack of perspective.

Conflict is a constant in the universe and how we handle this radioactive waste makes all the difference. Be objective and clear. Remain focused on the merits. Do not press the red button. Candidly, I have learned there is truth in being able to look a client in the eye and tell them they will either lose the day, or win the battle but lose the war, and to settle.

Some lawyers, like Gail Nunn, have tried Collaborative Law. This is a positive step. This begins with a promise not to go to war, sort of like what the Japanese put into their constitution after the Bomb was dropped on them.

What I want to leave you with is that where collaborative law won't work, and where you have to go to trial, collegiality is still the watch word. These are not personal issues; we work here. Do not press the red button. We have a long way to go people. Let's be careful out there. Have perspective, and maybe the market will turn around and we can retire earlier than we think today. *et*

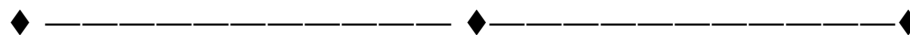
